Dear Mr. Schoenbaum,

Our law firm represents Mr. and Mrs. Paul K. Wickre, of Bethesda MD. We are writing to advise you that a blog you are hosting at www.thisainthell.us is in violation of your Software/Hosting Terms of Use and is potentially violating various state laws. We request that the blogs relating to Paul Wickre and Karen Williams be disabled immediately, and/or the entire license be revoked on the following grounds contained in this letter. This letter and addendums involve the following violations of the Terms of Service for your site 1) Mature Language/Porn; 2) Inciting violence, threats, abuse, harassment; 3) Defamation and Libel; 4) Violation of the Privacy of Mr. Wickre and Mrs. Williams; 5) Copyright Violations of the State of Maryland; and 6) Boosting the Search Engine Rankings of the Google Search page/rank algorithm.

Per your terms of acceptable use the blogger may not host offensive comments, that we will prove in our complaint and appendix. These go to the following in your Policies:

- Bestiality, non-consensual sex acts such as forcible rape
- Incites violence threatens violence and or contains harassing content or hate speech
- Is defamatory or violates a persons privacy
- Solicits conduct that is illegal under the general Law (state Codes of Statutes)
- Is malicious.

All of these violations will be shown, and we insist that the offensive content of the blog be taken down immediately, per your discretion "Rackspace reserves the right to take down or terminate use of its services at its sole discretion"

Overview of the Complaints:

The emphasis of the blog, while in parallel, relates to the general classification of content. The blog authors may change the emphasis from Mr. Monkress to Mr. Wickre, but the violations remain similar.

The Blog is being used to conspire, plan and activate numerous harassing phone calls, email campaigns, and at least one Denial of Service attack. The site has shown malice and intent to destroy jobs, careers and interrupt lives. There has been telephone harassment of 40-50 calls, which is being investigated by at least two State's Attorneys, as to about 8-10 victims including my clients. The blog threads call for murder, mayhem, maiming, torture, and go into every conceivable sex act, sex devices, including homosexuality, masturbation, bestiality anal rape, and sado-masochism. Most recently the blogsters have threatened to appear at my clients house. Shamelssly they even state a visit to my client's parents' cemetery to defile graves." ChipNASA Says:

MAYBE NEXT TIME ANYONE IS BY PARKLAWN, just behind the FDA building, just off Veirs Mill Rd, in Rockville Maryland in Montgomery County, Mary-farking-land, maybe they could stop by and "drop" Carrie Mae "Kay" Haynes Wickre, Paul K. Wickre's mother a little gift.

This blogster also actually writes content as to my client, having necrophiliac sex with his mothers corpse in another post.

The defamation and libel on these threads run the gamut from falsely alleging that my client is mentally unstable, an alcoholic, an abuser, misogynist, user of narcotics, a cross dresser, bankrupt, , a racist, a transgender specialist, and it also states false law enforcement convictions, among many other false claims.

In an effort to denigrate Mr. Wickre, a Vice President at APL, the blog "researchers" trace his ancestry, duplicate his mother's obituary, castigate his job, career and work, call for official investigations, falsely report his civil/criminal record, and much more. Mrs. Wickre who is a Capitol Hill Staffer for a senior member of Congress, who has nothing to do with this blog whatsoever, has also had her position, employment, pay grade, background, location and relationship with Mr. Wickre vilified. Furthermore, her private sex life is debased and exposed for all to speculate on.

The bloggers continually call for action in the form of kneecapping, beating Mr. Wickre with a 2x4, threats of visiting the family home, attacking the home with military grade weapons, calling their private work and cell numbers, sending more direct emails, and turning over my clients to various investigative authorities.

The bloggers have also publicized Mr. Wickre's civil and criminal record. This information is available on a web based browser owned and sponsored by the State of Maryland. The State has terms of use which must be read and agreed and strict rules of access, under the State Code. Here the owners of the blog, bypass the State access policies and directly post on Google unedited and incomplete data for all to see, bypassing the access policies.

Finally, as a direct combined effort, the blog posters work in concert to take the most denigrating information and artificially boost the Google page/rank algorithm to insure that the most negative information appear at the top of the first page. Details of this will be shown and involve the blog administrator who openly writes of artificially boosting the page rank to defame and harm Mr. Wickre.

Background

This blog has been in existence for 3-4 years and is run by retired or active Military that seek out individuals, whom in their estimation falsely received an award or commendation. The Supreme Court in United States v. Alvarez, 567 U. S. _____ (2012), heard arguments on the Stolen Valor Act, which made it a crime to falsely claim that you have won a military medal. The Supreme Court ruled that the display of decorations or medals incorrectly worn, was not a Criminal or Civil Offense and was protected speech under the First Amendment.

Not satisfied with the outcome of Law, this Internet band of vigilantes, has taken it on themselves to accuse, denigrate, report to the authorities, run back ground checks on traffic, civil records, defame with malice, conspire among themselves to destroy careers, livelihoods or companies and smear it over their blog as the only indictments that they can hurl. Their intent is to destroy careers, and particularly the careers of Veteran owned businesses that legitimately hold Federal Contracts. That is their motive and their tactics are reprehensible. This is a violent crowd with over 60% of the bloggers seeing combat action and 85% polled owning weapons. This gives my client great concern and reasonable fear for his safety and the safety of his family.

Mr. Monkress CEO of APL, was accused of claiming a Navy Seal Team IV status from his Navy service. He was called out for claiming Native American owned basis for set-aside contracts. These facts are in dispute. Mr. Monkress does have Service Disabled Veteran Owned Status. The Miltary blog, believes his company has received false enrichment, by claiming these statuses, which he never did and one is not an entitlement (Navy Seal Team IV). This had been going on some time, when Mr. Monkress took legal action which infuriated the Vets.

Mr. Wickre then got involved and wrote very noble and highline defenses of Mr. Monkrees including references to the Bible, 10 Commandments, the sin of bearing false witness and so on. The bloggers then turned their attention to Mr. Wickre and were determined to tar him with Mr. Monkress, tie the two together and make the worst aspersions possibly known in the English language as to vile acts, sex, threats, torture, and rape.

Ms. Williams is the wife of Mr. Wickre and is a quiet non-involved actor. Because of her relationship to Mr. Wickre the bloggers decided to personally attack her and put her personal information on the website, in an attempt to harm Mr. Wickre further. Her privacy has been severely disturbed for nothing more than being married.

The Bloggers have also confused and merged the identity of two distinctly different Paul Wickre's. One Paul Wickre is my client, a 57 year old Defense and Homeland Security Contractor, residing in Washington DC, with very little, if any, web history. However there is a second Paul Wickre who writes under the blog name of "Godless." This Paul Wickre is about 40, located in India, allied with the web through a 10 year old blog written by Steve Sailer, called "Gene Expression." This site espouses misogamy's, attacks transsexuals, denigrates women, is homophobic and racist. Gene Expressions actively advocated eugenics of the race by controlling and enforcing forced sterilization, Nazi like.

The blog contributors cannot separate and believe Paul Wickre in Washington DC, defender of Mr. Monkress, and the "Godless" writer are not one and the same. Thus they have heaped added enmity for my client, based on the perceived anti-social views of "Godless" Paul Wickre. The only linkage that exists to this 10 year old site of racist-misogynist Indian located Paul Wickre and my client in Washington DC, is the Rackhosting/Rackspace Hosting "This Ain't Hell website". For this reason alone, the website/license and URL has to be pulled, immediately as extremely defamatory to my client, as to paint him in the worst terms, by the blog contributors who are not aware of their mistake, but have essentially combined identities.

Terms of Service Violations- in detail

Your Terms of Service are very explicit as to the conduct from the licensee and the use of your software/hosting service. Your Terms of Service provide for several areas that are considered forbidden use and not in keeping with the terms of use of the software or hosting service: These are six (6) specific areas that apply to this Blog:

1) Abuse, threats, calls to violence, inciting at Addendum A.

Abuse

You may not use Rackspace's network or services to engage in, foster, or promote illegal, abusive, or irresponsible behavior, including:

- Use of an internet account or computer without the owner's authorization;
- Unauthorized access to or use of data, systems or networks, including any attempt to probe, scan or test the vulnerability of a system or network or to breach security or authentication measures without express authorization of the owner of the system or network;
- Collecting or using email addresses, screen names or other identifiers without the consent of the person identified (including, without limitation, phishing, Internet scamming, password robbery, spidering, and harvesting);
- Collecting or using information without the consent of the owner of the information;

- Use of any false, misleading, or deceptive TCP-IP packet header information in an email or a newsgroup posting;
- Use of the service to distribute software that covertly gathers information about a user or covertly transmits information about the user:
- Use of the service for distribution of advertisement delivery software unless: (i) the user affirmatively consents to the download and installation of such software based on a clear and conspicuous notice of the nature of the software, and (ii) the software is easily removable by use of standard tools for such purpose included on major operating systems; (such as Microsoft's "ad/remove" tool); or
- Any conduct that is likely to result in retaliation against the Rackspace network or website, or Rackspace's employees, officers or other agents, including engaging in behavior that results in any server being the target of a denial of service attack (DoS).
- Monitoring data or traffic on any network or system without the express authorization of the owner of the system or network;
- Interference with service to any user of the Rackspace or other network including, without limitation, mail bombing, flooding, deliberate attempts to overload a system and broadcast attacks;

Your Terms of Service provides that "you agree not to upload, post or otherwise transmit via the Online Mediums any content that: (i) is misleading, harmful, threatening, abusive, harassing, defamatory, offensive, violent, obscene, pornographic, vulgar, libelous, racially, ethnically, religiously or otherwise objectionable." Moreover, your customers have represented to you that they "will be in compliance with these terms of service." Not only is the blog inciting acts of violence, a linkage between the blog posters calls out for telephone numbers, our clients close personal friends and associates and directs that: "The heat should be put on these associates." Indeed they have, more than 12 employees of APL have received phone calls, hangups and direct telephone harassment designed to abuse, harass and annoy. The call for this conduct comes from the blog and is repeated over and over again. In addition vile and violent acts of conduct are called for repeatedly.

This behavior not only violates your Terms of Service but it is also obscene, harassing and threatening communications by computer. The calls have come from a self identified blog poster in Missoula, Montana. The Internet registrar indicates the identity, self exposed on the blog as:

Offensive Content

You may not publish, transmit or store on or via the Rackspace network or equipment any content or links to any content that the Rackspace reasonably believes:

- Constitutes, depicts, fosters, promotes or relates in any manner to child pornography, bestiality, or non-consensual sex acts:
- is excessively violent, incites violence, threatens violence or contains harassing content or hate speech;
- is unfair or deceptive under the consumer protection laws of any jurisdiction, including chain letters and pyramid schemes;
- is defamatory or violates a person's privacy;
- creates a risk to a person's safety or health, creates a risk to public safety or health, compromises national security or interferes with a investigation by law enforcement;
- improperly exposes trade secrets or other confidential or proprietary information of another person;
- is intended to assist others in defeating technical copyright protections;
- infringes on another person's copyright, trade or service mark, patent or other property right;
- promotes illegal drugs, violates export control laws, relates to illegal gambling or illegal arms trafficking;
- is otherwise illegal or solicits conduct that is illegal under laws applicable to you or to Rackspace; or
- is otherwise malicious, fraudulent or may result in retaliation against Rackspace by offended viewers.

We will show in the attachment, sexual threats of violence, consistent and continued use of foul language directed at another by a continual stream of invective, implied sex acts, sex mixed with violence and all targeted at our client, personally. Over 100 expletives, interspersed with foul and vile sexual violent acts are described or directed at Mr. Wickre.

Your Hosting Terms of Service provide that all contributors, including blog operators and comment posters represent and warrant that the content "is not pornographic." Your AUP states specifically that your services may be suspended or terminated for violation of this AUP in accordance with your services agreement with Rackspace.

Addendum B contains posts that violate the prohibition on pornography. For example, there is content containing the following from Addendum B.

Moreover, your customers have represented to you that they "will be in compliance with these terms of service", as to even their direct commentary.
