It is my understanding that a former Ranger, Mr. Bradley J. White's, military service and outstanding achievements are in question in family court. Though we cannot directly get involved, we felt that a letter from his former unit would help him and his cause. I can confirm that Bradley J. White was an indoctrinated Ranger with 2d Ranger Battalion, Ft. Lewis, WA. The veteran was also Ranger Qualified, meaning that he successfully graduated Ranger School and earned the proud and storied Ranger Tab in March of 2005.

I have included with this letter some documents, including his Enlisted Record Brief – a record of his time here as a Ranger. I have also attached the orders found for his Valorous Bronze Star and his Purple Hearts, as I was told that these are also in question. Albeit the veteran showed to be an outstanding soldier, his performance receded due to having become involved in what seems to have been an unhealthy and distracting relationship. Mr. White was arrested in May of 2006 under the charge of domestic violence; the veteran was then transferred units due to his actions.

As to the details of the veteran's discharge status, I am not privileged to such information as what was ultimately decided for the veteran under the Uniformed Code of Military Justice was under the command of his unit of transfer. If there are discrepancies in the veteran's service record(s), or his DD form 214, I encourage the veteran to retain legal representation and pursue the correction of his records. Unfortunately, it is not uncommon for veterans to encounter mistakes in their service records. The Army Review Board has the authority to correct such errors if the proper procedures are followed.

Together, let us ensure that deserving veterans' sacrifices are appropriately honored, including those of this veteran.






